#### **Total Market Equity Index Pool**

Seeks to match the performance of the entire U.S. stock market using a sampling strategy, investing substantially all its assets in a broad spectrum of small-, mid-, and large-cap stocks representative of the S&P Total Market Index.

#### **International Equity Index Pool**

Strives to provide long-term capital growth by seeking to match the performance of the FTSE All World Developed ex North America Index, an equity market index based on the market capitalization of over 1,000 predominately large companies listed in Japan, the UK, and developed countries in Continental Europe and the Pacific Rim.

#### **International Equity Pool**

Aims to provide long-term capital appreciation by investing in developed and emerging market equity funds, a money market fund, and, from time to time, international bond funds.
